SITE HOLDERS INFORMATION

Your application confirms your acceptance of the conditions outlined below

Each exhibitor must be familiar with and comply with the provisions of the Health and Safety in Employment Act 1992 and any other act of Parliament, Regulations or Bylaws.

In order to reduce to a minimum the possibility of accidents to the public attending the show, it is a condition of display that:

- 1) Machines be immobilised so that they cannot be started, or if it is desired that the machine can be started for purposes of demonstration, that the machine be adequately guarded to recognised standards, and be under constant supervision of someone in authority.
- 2) All exhibitors requiring the provision of electric power should state so in their application for sites, and will be required to comply with the regulations governing the supply of power at A&P shows. This requires that any person obtaining electric power at the show for use in operating portable devices, shall provide, and have in operation a suitable isolating transformer.

All implements, machinery and motor vehicles **MUST** be on the grounds by 9.00am on the day of the show. If you wish to participate in the Machinery Parade details of vehicles and machinery to be handed to the announcer prior to this parade (please ensure details are concise and legible)

All site holders must have Public Liability Insurance cover for the duration of the show. The committee will not be responsible for any claim.

Site holders are responsible for ensuring that all vehicles, equipment and exhibits are secure while not manned. The Association shall not be liable for loss of or damage to the exhibitor's property whilst on the show grounds.

All sites must be left in the condition in which they are found. It is the responsibility of the exhibitor to clear sawdust, woodchips etc from their site. Any holes dug must be filled in.

Exhibitors must have a fire extinguisher available on their site.
